To the rear of the building is a concrete ramp providing vehicular access to the western side of the building, utilised as parking and a loading bay. To the eastern side of the building is a canopy. The rear yard area has a hard stand concrete slab.

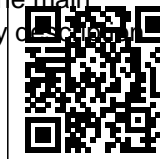
